# **2019 Training Program**

We are pleased to offer Caribbean-based fisheries professionals a training opportunity at the University of Florida, USA oriented towards "Facilitating Resiliency in Fisheries and Associated Ecosystems." The successful candidate will be hosted by Florida Sea Grant (www.flseagrant.org). The four-month training will focus on one of the following four topics: (1) fisheries governance and policy, (2) community-based fisheries comanagement, (3) data collection and analysis methods or (4) learning GIS.

This program is not open to students.

#### The Award

The award will include lodging in an apartment on the UF campus and an additional stipend of \$1,500 US per month for four months (\$6,000 US) for living expences. Round trip airfare for the successful candidate also is included. We will help the candidate acquire a visa and mandatory health insurance coverage (about \$500 US).

### **Important Dates**

Application opens: March 11, 2019 Application deadline: April 22, 2019 Award notification: May 6, 2019 Program starts: August 14, 2019 Program ends: December 15, 2019

The successful candidate will be matched with Florida Sea Grant-affiliated faculty whose expertise aligns with their professional interests and area of training focus selected. The candidate will apply knowledge gained to advance an

ongoing or proposed project of their choosing that is related to a need identified by their resource management ministry or government agency. At the conclusion of the four-month training the selected candidate will report progress made towards fulfilling their project at a University of Florida fisheries and aquatic sciences seminar.

# **Award Requirements**

Applicants must be employed by a fisheries resource management NGO, ministry or government agency located in the Gulf of Mexico or Caribbean region. This includes all island nations up to Bermuda, central and south American countries from Mexico south to Colombia, CRFM member states, and US territories in the Caribbean. At a minimum, applicants must possess a bachelor's degree (e.g., BA or BS) or a professional degree (e.g., Juris Doctorate) from an accredited college or university.

Candidates must be fluent in English.

This opportunity is not open to persons residing in the continental United States.
