Tobago Cays Marine Park (TCMP)

- 1987 Designated as fisheries
- 1997 Declared a Marine Protected Area
- 2006 Re-launched w/ user fee system
- 2008 Operating without Government subventions

WTP STUDY BACKGROUND

- Survey conducted by CEPro Consultants Limited, St. Lucia
- Work contracted through Ministry of Health and the Environment, GEF Focal Point (contracted 2009)
- 3. The WTP survey was conducted during first quarter of 2010 (Feb March, 2010)
- Final WTP report prepared in June 2010

STUDY OBJECTIVE

To assess the willingness of locals and tourist to pay to support effective management and conservation of parks, PAs and biodiversity in SVG

WHAT IS A WTP STUDY

- WTP is the maximum amount that an individual states that they are willing to pay for a good or service (DFID 1997)
- WTP study is design to answer the question "How much can we charge" (not what should be charge)
- WTP studies have been proven globally to be an effective methods to improve the financing required to manage PAs (Riley et al. 2006)

WTP STUDIES CONDUCTED AT MARINE PARKS

WTP STUDY PROCESS & BACKGROUND

- > Representative sample of locals and visitors were interviewed
 - 12 enumerators, one exclusively for TCMP
- ▶ Sample size was 400 (160 locals and 240 foreign visitors):
 - interviewed 55 persons for TCMP
- > Questionnaire (survey instrument) was divided into four sections:
 - 1. Socio-economic
 - 2. Determination of Park/PA visits
 - 3. Willingness to pay user fees for PA
- 4. Willingness to pay for biodiversity and ecosystem services

GENERAL WTP FINDINGS

- 80.56% of responses to the survey were from persons who indicated they were WTP
- 92% of respondents indicated that they were concerned about environmental issues in SVG.
- All respondents preferred the option of a "single-site daily pass" payment method for accessing the various sites in SVG.
- The results showed that there was a strong positive relationship between a respondent's interests in environmental issues and their WTP various fees.
- The mean maximum WTP to sustain the biodiversity of SVG ranged between EC\$74.87, and EC\$78.57

WAY FORWARD/CONSIDERATIONS

- A case for increase price reduce negative impacts, earn more from less visitors and optimize management efforts.
- Seasonal price increase can also be considered.
- > Improve collection efficiency, to cut out gaps/leakage
- Is there merit in charging a snorkel fee also?
- Fee terminology: a case for renaming user fees ? e.g. coral conservation & conservation fee

Summary of Findings For TCMP

- Non locals placed a significantly higher value for snorkeling and diving
- Entrance Fees charged at TCMP is not unreasonable when compared to Dominica and St. Lucia MPAs
- → Dive fees can be increased and still be within the range of other countries MPAs in the region (e.g. SMMA)
- Locals are not inclined to pay as much as non locals
- Consideration for a conservation tax that can be combined with entrance fees at some sites as part of departure tax.
